## TREASURER'S REPORT

Financial Report - Fiscal Year Ended June 30, 2019

Here are the financial results for the fiscal year beginning July 1, 2018 and ending June 30, 2019. Net fund-raising and donations were 14 percent above budget and four percent below the prior year. Gift shop net income was five percent above budget and three percent above the prior year. We awarded three \$1,000 scholarships, donated \$10,000 to the Ripon Opioid Initiative and \$12,037.16 to Ripon Medical Center. The following report details Auxiliary donations for the past five years. Cash remaining at the end of the fiscal year was \$25,292.54.

We had 70 paid members and one lifetime member in FY 2019. We have a lot to be proud of, so please ask your

friends, neighbors and relatives to be a part of our amazing organization!

Between our very successful fund-raising efforts and gift shop profits, we should be able to donate more than \$19,000 to Ripon Medical Center in FY 2020. We will also continue to award three \$1,000 scholarships to high school graduates pursuing a career in health care.

The Board has approved funding the purchase of a second gurney to improve the comfort of X-rays needed in patients with bad fractures. The cost is approximately \$14,000, leaving additional funds available for another need that may come up.

## SEWING COMMITTEE

Sew... You're looking for ways to get involved or help out?

The Ripon Medical Center Auxiliary's sewing committee needs you, your skills and your crafty friends! Our team is looking for Auxiliary members who sew, knit and crochet. We have a variety of projects we make for patients - all at your own pace and in the comfort of your own home - that include:

**Mastectomy Pillows:** used for patients after a mastectomy to provide protection and cushion from breasts being bumped, to protect the breast/surgery incision from seat belt straps and to assist in sleeping after surgery.

**Walker Bags:** used to hook on walkers so patients can store and transport their wallets, keys, phones and medical papers.

**Fidget Sleeves:** slipped on the arm, these hand-made "sleeves" have trinkets sewn on them allowing patients to pass time, reduce anxiety or take their mind off their medical situation.

**Fidget Blankets:** these small lap blankets are constructed of various fabric scraps and have gadgets galore sewn on them - zippers, buttons, ribbons, loops, laces, beads, etc. - and allow patients to fidget with while in the hospital, help pass the time, and ease their worries as they wait for test results, lab draws or physician updates.

**Prayer Shawls/Lap Blankets:** sewn, knit or crocheted, these pieces provide comfort and warmth to patients in the inpatient unit, outpatient departments like oncology, and to our emergency room. The blankets and shawls measure anywhere between 20 to 24 inches wide and 48 to 60 inches long.

We're always looking for new ideas on projects to create as well.

If you're interested in joining our sewing committee, I'd like to introduce you to our new Sewing Chairperson, Ann McDonald! In this role, Ann will share the sewing needs of the hospital with the Auxiliary sewing committee to ensure projects are completed. ## COMMUNITY HEALTH EDUCATION

### PROGRESS BEING MADE IN THE FIGHT AGAINST OPIOID ADDICTION

In March 2018, President Donald Trump traveled to New Hampshire to deliver a speech regarding the launch of a new administrative initiative to combat the escalating epidemic of deadly opioid overdoses.

Now, 16 months later, the Justice Department is reporting that the president's initiative has made substantial progress and that efforts are ongoing.

In releasing his "Initiative to Stop Opioid Abuse and Reduce Drug Supply and Demand," the president laid out three objectives:

- Reduce drug demand through education, awareness and preventing over-prescription.
- Cut off the flow of illicit drugs across our borders and within communities.
- Save lives now by expanding opportunities for proven treatments for opioid and other drug addictions.

According to a recent Justice Department statement, the initiative has gotten off to a good start roughly a year after it began in earnest.

One year ago, the Justice Department (DOJ) announced the formation of Operation Synthetic Opioid Surge (SOS), a program designed to reduce the supply of deadly synthetic opioids in high impact areas as well as identifying wholesale distribution networks and international and domestic suppliers.

Over the past year, 10 districts with some of the highest drug overdose death rates in the country, each targeted a county where they focused on prosecuting every readily available case involving fentanyl, fentanyl analogs, and other synthetic opioids, regardless of the drug quantity.

These districts worked with DEA Special Operations Division to track and coordinate these street-level cases and also received additional assistance from the Organized Crime and Drug Enforcement Task Forces (OCDETF).

“Our attorneys and law enforcement agents have spent the past year working tirelessly to disrupt the networks engaged in the trafficking of synthetic opioids. We are proud to share their successes in 10 of the districts most affected by this scourge,” according to Deputy Attorney General Jeffrey A. Rosen.

“The Department of Justice’s efforts have resulted in countless successes from California to Maine. We have successfully sought enhanced sentences in cases that resulted in deadly overdoses, and we have boosted cooperation among the partners involved,” he adds. “There remains much work to be done, but Operation SOS marks a crucial turning point in the fight against synthetic opioids.”

Specifically, according to DoJ, there are 10 districts participating in the program. Their efforts and some of their successes include:

- The Eastern District of California has reported a total of 27 Operation SOS investigations in which the narcotics seized have included kilogram-quantities of fentanyl, heroin, cocaine, methamphetamine, oxycodone and hydrocodone.

- The Eastern District of Kentucky has reported 15 investigations with six to eight new investigations being added monthly and has charged nine sentence-enhanced “death resulting” cases.
- The District of Maine has an additional 30 cases as a result of Operation SOS.
- The District of New Hampshire has had 41 cases through Operation SOS that have resulted in indictments with fentanyl being distributed in 39 of those cases amongst other drugs.
- The Northern District of Ohio has indicted 71 defendants under Operation SOS and has seen a 12 percent decrease in overdose deaths from the previous year.
- The Southern District of Ohio has 58 Operation SOS investigations and of the 58 investigations, 52 involve fentanyl distribution.
- The Western District of Pennsylvania noticed the decline in overdose deaths in the county they originally had targeted. This decline was attributed to a large number of people moving out of the targeted county to attempt to circumvent the U.S. Attorney’s Office’s efforts. The U.S. Attorney’s Office has refocused their resources to target the county where fatal overdoses have increased the most.

In addition to curbing the smuggling of illicit opioids, the Trump administration also seeks to curtail opioid prescriptions from doctors and primary care providers by one-third, the White House says.

Also, the president’s program includes treatment resources and initiatives for Americans addicted to opioids and addressing other factors driving the high addiction rate.
