


## **Strategic Planning Committee Report - Spring 2022**

The Strategic Planning Committee met during the Partners February Board meeting. Five committee members attended in person and two attended virtually. Members continue to work on goals set for 2021-2022.

Goal #1 is to improve communication among volunteers at all levels throughout the state.

Peg Larson has completed a process ensuring that volunteers holding positions on local, district, or state boards receive the Reaching Out newsletter. If a volunteer should be receiving it and is not, contact Peg Larson or Patricia Franks.





To enhance communication at the local level, a new volunteer orientation form with information about Partners was created by Julie Steiner and John Tully. Those who are involved in new volunteer orientation will be informed.

**Goal #2** was developed to communicate the value of membership in Partners.

A virtual "table" was set up on the Advocacy Day Leader Pass platform in 2022. This included text and a video explaining the benefits/value of belonging to Partners of WHA.

Goal #3 established further development and implementation of the leadership tool kit, specifically assigning mentors for leadership development, implementing revisions, and collection of data for evaluation.

The mentor list was reviewed, a personal phone contact was completed to each person on the list with meaningful comments received. A letter summarizing the purpose and procedure for matching mentor/ mentee was emailed to each new district chair and to each mentor, along with a Contact Summary Form to track mentor/mentee contacts. There has not been much feedback from mentors possibly due to COVID situations.

The question was posed as to who will review all forms to keep information current. This will be added to the job description of the immediate past president.

Members of the committee discussed considerations for future Partners gatherings (applying to the May event).

- Options to improve the safety and comfort of participants attending meetings or other gatherings were considered, including individual comfort and organization restrictions. Protocols will be followed according to the local guidelines in place at the time of the event, or the current CDC recommendations. Individuals should take responsibility and be considerate of others—if feeling unwell do not attend an event.
- Convention—going forward will we continue to have both virtual and in-person opportunities? What will the cost difference be to attend meetings in-person vs virtual? (Virtual presentation is costly.) This can be a better choice for volunteers who are unable to attend in-person, or have difficulty with transportation or costs of lodging. When registering for a virtual meeting, the cost is assessed for each person (not one paid registration for a room of participants) How do we handle last minute cancellations?

As we go forward as an organization, we will likely be addressing many new questions.

Diane was the 2010 Partners of WHA Best of the Best Award Winner. She was outgoing, caring,

dedicated and will truly be missed.

# **Community Health Education Report**

Spring is a time for renewal! How fitting is it to enter this spring season and experience a sense of "newness"—an uplifting feeling in our daily lives as we begin to put the COVID-19 pandemic behind us. Although the worst of the pandemic seems to be over, it will take time to fully recover.

This year's WHA Advocacy Day presentations and discussions focused quite a bit on COVID-19. And rightly so, as it had (and still has) a major impact on health care in Wisconsin and across the country. We are all aware of the burden it has placed on hospitals and hospital staff (volunteers included).

The keynote speaker at WHA Advocacy Day, Dr. Scott Gottlieb, shared several keys points related to the handling of the COVID-19 pandemic.

- Data Collection: the CDC had a difficult time collecting data as the current system does not look at real-time data. Instead, they created a model estimate from data received from China, Italy, and the UK. The U.S. Department of Health and Human Services created their own system to collect reliable data directly from hospitals nationwide.
- High Demands: the need for more frontline health care staff, more surveillance, and more testing was challenging.
- Collaboration: more sharing and messaging of complex information needed to occur to reduce confusion and maintain/increase credibility.
- Future Plans: learn from the mistakes made and invest in preparedness for the next health care crisis.

Series 4 of CHE articles on Infectious Disease will be published in May. The topics will include hepatitis and salmonella. This information can be found on the Partners of WHA website under the Health Education tab.

I look forward to seeing many of you in person or virtually during Spring Tour in April and May.
